### **Chairman's Report**

### Planning and local developments

Planning applications and new developments seem to have grown in number in the last year. In particular, I have already mentioned in past newsletters the sudden surge of developments on the borough boundary with Wandsworth by the River Wandle. The earliest proposal was the redevelopment of the main part of the Haslemere Industrial estate. The latest has been the 'Wellington Works' proposal to build a block of flats to the rear of Durnsford Rec; This is being led by Goldcrest Land PLC.

Goldcrest have consulted locally quite extensively and have met with WPRA representatives several times in the last few months. As a result of their various discussions, they took a decision to lower the height of the building. This was a welcome decision. Also they confirmed that access to the site from Dawlish Avenue would be restricted to pedestrians and disabled persons. Access to the site via Havana/Wellington does pose other problems of increased traffic around the school area and for those living in Wellington Road, in addition to the traffic already accessing the industrial estate via Wellington Road.

A lot of discussion with developers generally has centred around the possibility of establishing a connection from the Haslemere side through to Durnsford Rec and also the possibility of a pedestrian bridge across the Wandle from the Ravensbury Terrace area. The Wandle Valley Forum article in our last newsletter mentioned this. Certainly Goldcrest have been open to views and suggestions and shown a willingness to assist where they can. They are to be commended on their approach to local consultation which is in contrast to many development companies who, for the most part, conduct consultation with a largely tick box attitude.

### The 'Glasshouse' in Arthur Road

In my last report I mentioned the planning application from the owners to add a further floor to the building for Commercial use. There were a number of objections to this application from neighbours, who would be directly affected, and also Councillors and the Association. This application was subsequently refused by Merton Council on the basis that 'by virtue of its size height and design it would result in an unacceptable increase in height of the building that would be detrimental to the Arthur Road streetscene and would also be visually intrusive and detrimental to the amenities of occupiers of residential properties in Farquar Road and Strathmore Road..........'.

Surprisingly, despite this comprehensive rejection, another application has been made to Merton, again wishing to add a fourth floor but this time for two residential flats. This proposal, as with the last one, seems entirely inappropriate for this location and hopefully will be rejected again.

### Merton Council action on pollution

On pages 12 and 34 you will find an article giving the background to a decision by Merton Council to create a levy on all diesel cars in Merton which are subject to

parking permits. Apart from other considerations, this levy attacks only one section of the users of diesel cars in Merton and therefore is highly discriminatory. There are many reasons why we should all be very concerned by the introduction of such an ad hoc and arbitary levy but particularly because action to deal with air pollution and the problems of diesel engine emissions needs to be addressed on a pan London and eventually country wide basis by the national government, not by individual councils.

It has been brought to my notice that a local resident of Wimbledon Park has made an official complaint to the Local Government Ombudsman about the action of the Council in this regard. The main planks for objection are: inadequate consultation and that it is a discriminatory policy. If anyone is interested in seeing the full detail of the complaint, you can get in touch with me.

### **Boundary Commission proposals**

In my last report I wrote about the proposals and provided details of the proposals and the response from the WPRA. A second round of consultation has commenced based on the responses received in the first one. The results of the first consultation are available on the Commission website. Overall the local response to their proposals was negative. By the time you read this report the consultation period will be over. However, I will be writing to the Commission reiterating the views that we expressed before, both verbally to the Commission and in writing. I think our proposals were sensible and, importantly, met the criteria set down by the Commission. These were in line with the response from the Wimbledon Society whose views we supported.

### Crossrail 2

Stephen Hammond's update on Page 7 confirms the latest position on Crossrail 2. It seems unlikely that we will hear any further detail until June or July. If there is news before then, we will publish it on the website.

### The new South Wimbledon-based Harris Academy

According to a recent circular from local Councillors, this new school will be part of the Harris School Federation and from September 2018 will be run from its initial site on Whatley Avenue (formerly Merton Adult Education Centre) before transferring to its permanent site on High Path in South Wimbledon in 2020. Harris proposes to use what are described as 'nodal points' to shape the school's admissions policy and children who live closest to these points will be prioritised for places.

The three nodal points it is currently proposing to use for admission to the school in those first two years would be Wimbledon Park Station, Wimbledon Chase Station and the front entrance to Merton Abbey Primary School. It has yet to be decided how the numbers will be allocated.

This is an important development affecting residents of Wimbledon Park. There was, apparently, a public meeting held in Wimbledon Park school on the 7th March and a period of consultation until the end of March. However, I am not certain how well publicised this was to local residents. *Iain Simpson* 

### **Update from Stephen Hammond MP**

I am grateful for the opportunity to write again in the WPRA newsletter. ### Crossrail 2

Crossrail 2 remains one of the biggest local issues we are facing here in Wimbledon Park. A further consultation on the preferred new route option, was planned for November last year, but when this deadline appeared to



be slipping, I asked a Prime Minister's Question in the House of Commons and found the consultation was to be delayed until a business case was submitted to the Government by TfL.

This business case has now been submitted and I have also submitted a written question to the Secretary of State for Transport to ask what their timescale is for considering it, and when they expect to hold the next consultation. I expect we will hear more about the next consultation and route option in June or July.

The Government's insistence for a business case shows they are concerned about the costs and benefits of the project. However, it is my view that the project is more likely than not to go ahead.

When the consultation is held, I will do everything I can to publicise it to ensure that local residents' voices are heard.

### **Brexit**

Many local residents have written to me with their views on Brexit. I campaigned and voted to remain, but the reality is that from the moment the result was announced the United Kingdom was on a course to leave the European Union. Since then, I have been fighting to make the inevitable Brexit work as well as possible for the country, Wimbledon and London. This is what I will continue to do on behalf of my constituents.

I have been busy holding the Government to account in Parliament. I called for a White Paper to be published, I've been making the case for protecting our financial services sector, I added my voice to the calls for our Parliament to vote before the European Parliament, which the Government conceded, and asked the Home Secretary to put the rights of EU citizens into UK law in the Great Repeal Bill, which she has accepted.


It was lovely to wander the streets over two nights and see so many people out, not hurrying, just wandering with the only purpose – to spot something fun, beautiful, amusing and amazing!

### The best way to tackle air pollution?

The Council is about to introduce a surcharge on diesel vehicles in the borough, based on parking permits only. Therefore, this will not include those that can park off road or the huge amount of daily through traffic in Merton.

On 14th November 2016 the Cabinet agreed to the introduction of a levy charge for all diesel vehicles that have a Resident, Business or Trade parking permit with the introduction of £150 surcharge phased over a 3 year period - £90 in 2017/18, £115 in 2018/19 and £150 in 2019/20.

Also, a Resident parking permit charge for electric vehicles is to be set at a discounted rate of £25 per annum.



The Council is to review the impact of the diesel surcharge for a period of 2 years, with a view to the introduction of a comprehensive emissions based parking scheme.

To implement the above, the Council is undertaking a Statutory Consultation, starting on 12<sup>th</sup> January 2017 and concluding on 3<sup>rd</sup> February 2017, to amend all the Traffic Management Orders pertaining to Controlled Parking Zones.

According to the Council, the introduction of a diesel surcharge is designed to highlight the disproportionate impact these vehicles have upon local air quality and ill health.

They say the overall aim of the scheme is to influence residents and business users to consider changing to lower or zero emission vehicles with any revenue derived from the scheme reinvested to support local sustainable transport initiatives and necessary infrastructure. Successful introduction of this type of scheme demonstrates the local authority's commitment to reducing emissions and improving air quality towards national objectives.

According to research carried out on behalf of Merton Council, there are 15074 vehicles with parking permits. These are represented by vehicles split 63% petrol and 35% diesel.

The introduction of these measures was discussed at the Overview and Scrutiny Committee meeting on the 12<sup>th</sup> December after being 'called in' by Councillors David Simpson and Daniel Holden.

### Reflections

We recently celebrated our Silver Jubilee as residents of The Grid area of Wimbledon Park. Inevitably, I began to reminisce about what our neighbourhood was like when we moved here, and have tried to establish in my mind just from memory the main changes that have taken place in the area since we arrived.

By professional formation my interest is generally focused on the physical aspects of the buildings and the public spaces in between them. From this perspective, perhaps it can be said that not much has changed, in particular on The Grid, which retains its strong residential character. Although the majority of the terraced houses have now incorporated further accommodation in the loft space, this has been done, except for a few cases, without compromising the external appearance of the houses or the street scene.

When you catch glimpses of the changes at the rear of the properties, then it becomes apparent that the use of the land has been clearly intensified. Externally, the demise of most of the old corner shops on streets such as Revelstoke Road has meant a loss in the variety and character of the area.

The main local commercial area in Arthur Road sustained by the attraction and movement of the residents towards and from Wimbledon Park tube station has seen more changes, in particular the lower end of the road towards Durnsford Road, where more recently new residential led developments have taken place. These new buildings have, in terms of massing, respected the overall height of the older buildings further up on both sides of the road. As to the architectural character of the new buildings, one could say that perhaps not enough attention was paid for these to reflect in a contemporary manner at least the materials and proportions found in the overall context.

The uses at street level have indeed changed following commercial demands and trends. Banks no longer have outlets at Wimbledon Park, the Public Library also disappeared and, as in any typical High Street, there is now a bigger range of food and café shops providing local residents with an option to stop their journeys for a chat on the way home or to work.



The extension and renovation of the Coop store has made this a popular destination balancing the attraction of the tube station. Christ the King Church continues to play an important role in the character of our local town centre.

The approach to the tube station through the meandering Arthur Road from the top of the hill offers quite a lot of changes, with new mostly residential developments that have taken place almost unnoticed over the period, due to the strong presence of mature trees and high brick boundary walls onto the street.

We can now see the minimalist approach next to St Mary's Church and contemporary design town houses almost opposite the Artesian Well. We can also see new traditionally designed larger houses that attempt to replicate the scale and detailing of the former late Victorian or Edwardian original single large houses that have been demolished to give way to the intensification of the use of the land.

### **Introducing Wandle Valley Forum**

Wandle Valley Forum was established in 2005 to bring together people and organisations that care for the River Wandle and its diverse network of open spaces and communities. We are supported by over 100 community groups, voluntary organisations and local businesses, including Wimbledon Park Residents Association. We provide both a communications network and an independent voice for the different communities and organisations in the Wandle Valley Regional Park. Among other things Wandle Valley Forum:

- is the primary consultative forum for the Wandle Valley Regional Park Trust, four London boroughs, Greater London Authority and other statutory bodies on Wandle Valley issues
- provides an independent voice which speaks out on issues that matter to the future of the Wandle
- provides information and support through regular publication of Wandle Bulletin and via our website (<u>www.wandlevalleyforum.org.uk</u>), twitter (@WandleValley) and Facebook
- organises events and workshops which bring people together from across the Wandle Valley
- feeds in views on planning policies and development proposals to protect and enhance the river and the surrounding Regional Park
- provides two members of the Wandle Valley Regional Park Trust Board

The Wandle Valley Forum Charter sets out our priorities and this was informed by the views of all those who support us. It is available on our website. Wandle Valley Forum is run by volunteers and is a not-for-profit group.

During the last two years we have worked hard to influence the spate of developments in Earlsfield and along the river. We are looking for Merton and Wandsworth Councils to collaborate and harness this development to secure improved access to and across the river and provide better connections to nearby open space and rights of way. This work included a joint letter signed by local



Councillors, Wimbledon's MP, WPRA and other local organisations. We have also met with Crossrail 2 to discuss its plans for Weir Road and ensure they respect its location by the river. In all this we have pressed for action to close the gap in the Wandle Trail where the river goes under the main railway line out of Waterloo.

Looking ahead we will be leading the celebration of the Wandle this September during Wandle Fortnight. We are hoping all our supporters will be putting on Wandle-related events and activities and we will even have a small amount of Lottery money to distribute to help.

We are all the richer for the wildlife, green space and heritage of the Wandle Valley and if you would like to stay in touch with our work then sign up at our website.

### The VINEYARD HILL ROAD SURGERY



There has been a practice at 67 Vineyard Hill Road since the early 1970s. However, following the announcement of the previous partners' retirement in 2014, it faced closure. NHS England initiated local patient consultation with the likely outcome that the list would be dispersed.

The Partners from the Groves Group took over the partnership in March 2015 and the practice was saved from closure. The Groves Group has 7 partners, 2 of whom work regularly at the Vineyard Hill Road Surgery alongside 3 salaried GPs. Their ethos of maintaining local care in a community environment whilst encouraging autonomy has been fundamental during this transitional period for the local community. They are supported by a Practice Nurse, Health Care Assistant, Manager and a valuable reception and administration team.

The premises were acquired by third party Assura Properties with a twenty year lease, so the local community can be reassured of the long term commitment from the Groves Group to continue providing local services.

The Groves Group has a strong caring vision and is committed to sharing their experience to maintain quality services to local surgeries which are supported

within a group organization structure and responsive to local needs.

Opening hours are 8.00 am to 6.30 pm, Monday to Friday and we are pleased to announce that appointments are now available on Saturday mornings twice a month. We are also currently working with our local CCG to provide Thursday evening appointments in the near future.

Patients can register with 'Patient Access', which enables them to book appointments, request repeat medication and view results online, and we work closely with our local pharmacies to ensure prompt prescription turnaround.

Councillor David Simpson said that he was in favour of measures to improve air quality but that this should be done at a regional or national level. His view was that the surcharge is a piecemeal measure that has been used as an opportunity to raise revenue for the Council. He said that the impact of the surcharge would be felt predominantly in the west of the borough, as that is where the majority of controlled parking zones are located and that this was therefore a punitive and tokenistic measure.

Councillors David Simpson and Daniel Holden made further points in response to questions: vast majority of hotspots are caused by vehicles from outside the borough; although the level of pollutants from vehicle emissions is certainly higher than that indicated by manufacturers' tests, modern cars have lower levels of emissions; air quality is affected by lots of factors across London and can't be controlled by local measures taken in isolation; a surcharge should be imposed at London or national level for all diesel vehicles.

A motion for the matter to be referred back to Cabinet was defeated.

The key legal framework allowing for parking operation and enforcement duties comes under the Road Traffic Regulation Act 1984 and Road Traffic Act 1991.



Designation of parking is achieved through traffic regulation orders.

During the 1990's people were encouraged, by the introduction of road tax incentives, to buy diesel vehicles on the basis that they produced lower carbon dioxide emissions. At that time there was apparently little or no appreciation of the health impact of particulate matter or Nitrogen Dioxide.

Now diesel vehicle owners are to some extent being punished for following what they assumed was good advice. A fair way of dealing with the problem needs to be found. Low emission Zones have been introduced in many big cities throughout the country. This surely must help but perhaps the most sensible thing would be for the Government to introduce an age related programme of scrappage of diesel vehicles over an agreed time frame.
